## Northern Lakes Propane – Terms and Conditions

### For Pre-Buy and Budget Propane Contracts

- Buyer agrees to contract for and pay a set price for propane delivered during the contract season. This price is only applicable for the gallons you contract. **Once all contract gallons have been delivered during the contract period, any additional gallons delivered shall be at the daily posted spot price.**
- Propane orders during the contract season must be a complete fill as long as contract gallons remain. At the end of the contract, minimum propane deliveries apply regardless of the number of gallons left on contract. These minimums are; 400 gallons on a 1,000-gallon tank, 200 gallons on a 500-gallon tank and 150 gallons on a 320/325/250-gallon tank. **Minimum gallon requirement does not apply to those on the “Forecasted Delivery” program where each delivery requires a fill.**
- Fuel for secondary homes and businesses are taxable. We reserve the right to add sales tax at time of delivery if necessary. By selecting a non-taxable plan, you are stating that the fuel is for your primary residence or other tax-exempt use.
- Seller reserves the right to add delivery charges in the event of terrorist attack, natural disaster or other disruption of pipeline delivery, pandemic and/or propane availability.
- Signing this Propane Contract **DOES NOT** automatically place you on the “Forecasted Delivery” program for fuel deliveries. Contact Northern Lakes Propane for more information on the “Forecasted Delivery” program.
- Pre-payment or installments will be credited to buyer’s account with Northern Lakes Cooperative. Northern Lakes Cooperative, as seller, agrees to deliver the product and charge buyer’s account accordingly.
- Contract pricing will begin on June 1, 2022 and will continue through the 12-month term, ending May 31, 2023.

#### Terms Specific to Pre-Buy Contracts

- Contracts are available for 400 or more gallons.
- Your account must be current and in good standing to initiate your 2022/2023 contract.
- Unused dollars at the end of the contract term can be credited towards your next propane contract or non-contract delivery.
- Any dollar credit on buyer’s account will not automatically be turned into a contract. Buyer must indicate on the contract how they would like the credit to be used.

#### Terms Specific to Budget Contracts

- Budget contracts are available for 400 or more gallons.
- Pay equal monthly installments determined by contract term.
- The Northern Lakes Cooperative requires an ACH (automatic withdrawal from checking or savings account) for payment or if you choose a monthly billing option, a credit card **must** be provided to be used in the event the account becomes delinquent.
- The first monthly installment must be received when contract is submitted.
- The monthly payment will also include a Service Fee of \$10.00.
- Your account must be current and in good standing to initiate your 2022/2023 budget contract and remain current for the duration of the contract. If your account becomes delinquent, your contract will be null and void and deliveries will be made at spot price at a cash on delivery basis.
- Unused dollars at the end of the contract term can be credited towards your next propane contract or non-contract delivery.

#### Patron Rewards

Receive 1% cash back each Cooperative fiscal year on all of your purchases. Cash back is refunded to you via a Co-op Rewards Voucher which can be used at any of our stores. Must have current Patron Rewards card to participate.
